#### Primary Focus Points for the Year:

- Review and Interpretation of UCSF Bylaws as requested by other Senate Standing Committees and Councils. Rules & Jurisdiction Committee (RJC) members reviewed eight items of business:
  - i. Bylaw revisions for Committee on Educational Policy and the School of Medicine Faculty Council
  - ii. Committee on Courses of Instruction: Request for Interpretation of Regulation 750A
  - iii. SF Regulation 775(H) revisions to identify the accurate section of the regulation which references repeating courses.
  - iv. SOP Bylaw and Regulation revisions related to approval and implementation of new curriculum and grading system. These included the creation of the new divisional SF Regulation 781 and minor revisions to SF Regulation 775A.

### **Going Forward**

Pending issues for the Academic Senate Committee on Rules and Jurisdiction to carry forward into 2018-2019:

- Continued review of proposed bylaw revisions
- Working with both SOD and SON on revision of bylaws and regulations pertinent to the specific schools
  - While SOD is already pursuing this, the request to SON is due to them being the sole school who hasn't done so in recent years. SON may have little to no revisions, but the request to their Faculty Council was made nonetheless.
- Academic Senate Office is initiating a bylaw/regulation audit in 2018-2019. This will result in new business for RJC come spring 2019 at the earliest.
- Ongoing discussion and outreach for community service and volunteering efforts by faculty and RJC support
  of reimbursement to faculty for doing so. This will be moved up to the EVCP/Chancellor's Office.
