Primary Focus Points for the Year:

 - 1. Commence review of both bylaws and regulations for School of Nursing Faculty Council. To be completed in 2019-2020
 - ii. Senate Office Bylaw Audit
 - 1. Review and approval of proposed editorial corrections to bylaws and regulations
 - 2. Review and respond/approve on proposed committee/council substantive revisions to bylaws and regulations proposed by the Senate Office, and approved subsequently by the respective committee/council.
- Support of the Chancellor's Senate Faculty Academic Renewal Funds to fund the Community Service & Volunteering Awards to support faculty participating in non-clinical volunteer activities in their community offsite of UCSF.

Going Forward

Pending issues for the Academic Senate Committee on Rules and Jurisdiction to carry forward into 2019-2020:

- · Continued review of proposed bylaw revisions
- Working with SON on revision of bylaws and regulations
- Academic Senate Office is continuing their audit of bylaw/regulations in 2019-2020. This will result in new business for RJC come fall 2019 at the earliest.

Divisional Business

- Faculty Council Inquiries:
 - a. RJC was asked to determine a process for voting off excess ex officio members in situations where there is an imbalance of ex officio and voting members on a Faculty Council. In particular, when there are no ex officio volunteers willing to exit and the School's Department Chairs have voted against adding an additional voting faculty member.
 - Are ex officio members included as part of the quorum? The UCSF Senate Office uses Sturgis <u>The</u> <u>Standard Code of Parliamentary Procedure</u> as a basis for its office, committee, and council processes. In reviewing Sturgis on this topic, there is no clear definition. Quorum is simply established by the number of voting members present. So if ex officio members are considered to be voting, then they are included in the quorum.
 - i. A way around this issue, RJC opined, is to set quorum at an arbitrary number, which allows the committee to conduct voting business even in the absence of ex officio members.
- Registrar's Office Inquiry:
 - a. SF Regulation 775(G)(2): Do the last two sentences in subsection 2 actually go with the broader 775(G), and subsequently should be moved?
 - b. Upon discussion, RJC members agreed with the Registrar's Office and determined that these two sentences should be moved up in the primary overview language in 775(G) and not be included in subsection 2. (Appendix 5)
